

TEMPORARY WATERING EXEMPTION REQUEST FORM



Complete this form to apply for a *temporary* watering exemption for your new lawn or garden.

You may apply for an exemption to temporarily water outside current water roster restrictions if you have planted a new lawn or garden. Garden beds planted at the same time as laying the lawn may be included in the exemption.

Exemptions for new lawns are issued from the date that the new lawn is installed, so you should only book your exemption a few days in advance. Once you have submitted the form the dates of your exemption cannot be altered.

Muceha Water will consider your request and advise you whether your watering exemption is approved.

If reticulation is installed by a landscape contractor, builder or developer, the owner is responsible for any breach of the exemption conditions.

Section C – Exemption Conditions

- Random inspections may occur, if you don't comply with the exemption conditions you risk a \$100 fine.
- All breaches will be the responsibility of the property owner not the person who installed the lawn, plants or reticulation system
- A reticulation system can be used to water a new lawn and/or garden in summer for up to 42 days, up to 3 times per day.
- All exemptions cease at the end of the approved exemption period. Normal watering rosters apply after this date.
- At the end of the temporary watering exemption period the settings on your reticulation controller must be amended in line with the sprinkler roster for your area.
- You will be billed for all water you use, including that used with a temporary watering exemption. The additional water use may result in a higher water bill.
